Annex A – Processing of your personal data for the application and data transfer to China

I. Details of the processing

KI DUS Sprach- und Kultur-Institut GmbH (“**we**”, “**us**”, “**our**”) processes the following personal data for carrying out your application as part of the “China-Germany Youth Interns Exchange Programme” (“**Exchange Programme**”) (Art. 6 para. 1 lit. b GDPR):

- master data (name, date of birth, place of birth, country of birth)
- contact data (email address, telephone number)
- language skills (native language, proficiency in Chinese and English) ②
- education (current university, major)
- other application data (contents of application documents, for example, photo, CV and certificates)
- internship preferences (duration, industry, position, city)
- written correspondence regarding the application

We transfer your personal data to **Yvfeng Mandarin.education, Wuxi Jiangsu China, 21402 (“Chinese Partner”)** in China who coordinates the internship with local companies for the Exchange Programme. The Chinese Partner processes your personal data to find a local company and for the coaching programme so that you can get an interview, internship contract, work permit and coaching support locally in China.

II.

Adequacy decision

The EU Commission has not issued an adequacy decision for China (Art. 45 para. 1, 3 GDPR). This means that the EU Commission has not yet positively determined that the country-specific data protection level of China corresponds to that of the European Union on the basis of the GDPR.

III.

Appropriate safeguards

The GDPR requires appropriate safeguards for a data transfer to a third country. These can be, for example, standard contractual clauses. Even though we rely on your consent for the data transfer, we have additionally concluded standard contractual clauses with the Chinese Partner to further safeguard the data transfer.

IV. **Possible risks**

China is a so-called “third country” (a country outside the EU/EEA) and does not provide an equivalent level of data protection to that of the EU. Due to the absence of appropriate safeguards, there is particularly a risk that

- government authorities will access your personal data and you will not be able to enforce your data subject rights;
- third parties in China receive your personal data and process it beyond the purpose of carrying out the application; or
- you may not be able to assert or enforce your data subject rights under local law.

V. Retention

We will delete your data upon expiry of a retention period of **10 months** after your completed application in order to be able to respond to any follow up questions that you may have during said retention period.

VI. General information
